Water meters and backflow devices must be accessible for repair and maintenance.

Curb boxes must be accessible at all times

A **plumbing permit** is necessary, a backflow preventer - dual check valve (Watts #7), pressure reducing valve (Watts UB-5) and thermal expansion tank must be installed on all **domestic water services to residences**.

**Commercial connections** will require testable backflow prevention devices, (Watts 909,009,709,007), pressure reducing valve, and thermal expansion tank. **Note:** Before any testable device is installed, a plumbing permit and a completed DEP design data application (permit) must be obtained.

**Backflow prevention device installation permits** are \$100.00 per device.

**Backflow prevention device test** is \$75.00 per test.

**Commercial, Industrial, Multi-Unit and Multi-Family Dwellings** will be assessed \$5,200.00 per unit or the service size; whichever is the greater amount. Main line extensions will be charged for all water used for filling, flushing and testing.

**Contractor water license fee** is \$100.00 per year.

**Final meter reads** are \$50.00 + minimum bill or metered water use.

**Fire flow test** is \$150.00 per hydrant flowed.

**Fire hydrants** will be billed \$250.00 annually.

**Fire protection sprinkler system connections** will be billed \$1,000.00 annually.

**Hydrant use** is \$150.00 + minimum bill or metered water use.

**Inspections/Labor Charge** is \$50.00/Hr. No work is to be covered without an inspection, all valves are to be operated by District personnel only.

**Meter test:** \$150.00

**Service to repair**—replace meters, turn on water, shut off water, will be \$50.00/Hr.

**Shut off/Turn on water fee** (delinquent accounts): \$75.00

**Water theft fine** \$1,000.00 per offense (each day is a separate offense).

**Lawn sprinkler systems** must have rain sensors, proper backflow prevention devices, plumbing permits, and timers set to comply with the outdoor water restrictions in effect:

Level #1 No restriction

Level #2 Outdoor water use between the hours of 7PM to 7AM

Level #3 Outdoor water use between the hours of 7PM to 7AM + odd / even day use restriction

Level #4 NO outdoor water use

## Water Rates (adopted March 7, 2023):

Minimum Charge (all meter sizes includes 0 gallons) = \$42.50 per quarter

\$8.03 / 1,000 gallons 0 - 20,000 gallons

\$8.91 / 1,000 gallons 20,001 - 55,000 gallons

\$9.58 / 1,000 gallons 55,001 - 80,000 gallons

\$10.26 / 1,000 gallons 80,001 - 180,000 gallons

\$11.04 / 1,000 gallons over 180,000 gallons
